Bloodborne Pathogens Training Courses*

BBP training which meets Cal/OSHA's Bloodborne Pathogens Standard 8 CCR 5193 is required for persons who may be exposed to BBP while performing their routine work functions. This includes, but not limited to: tattoo artists, permanent cosmetics professionals, and body piercers. Additionally, Cal/OSHA and The Safe Body Art Act (AB 300) requires that the training and training material must be **specific to performing body art**. BBP training contact time must meet a **minimum of 2 hours**. Training must be renewed annually. Records must be kept for a minimum of 3 years. Should a class be taken that does not meet these requirements, DEH will require that another training class be taken following the same requirements. DEH is not responsible should a class be taken that does not meet these standards.
